Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

There are approximately 4-5, relatively immature trees, which require some lopping as they overhang our property (12 Inner Hey) by some distance. The trees are planted on land belonging to Inner Hey House but are directly adjacent to the fence belonging to 12 Inner Hey. We have consulted a tree surgeon who has advised us on the above. This work was last completed in 2016 (<https://www.kirklees.gov.uk/beta/planning-applications/search-for-planning-applications/detail.aspx?id=2016/90288>) The trees are Sycamore, Hawthorn, Ash, & Elder.

There is also one Sycamore tree which stands in our front garden (Carrs Road side). This also needs lopping as it's nearly overhanging our house now.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
