## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

All trees detailed below are subject to TPO's which were added circa 35 years ago.

3 Lime trees, referenced as 1,2 &3 on the sketch map (we suspect one of the lime trees may be causing large cracks in the mortar of an adjacent stone wall. The wall has been there for over 100 years. As suggested, we will repair the mortar and see whether the cracks re-appear)

2 Sycamore trees, referenced 4 & 5 on the sketch map

1 Copper Beech tree, referenced 6 on the sketch map (this is located close to a large bump in the block paving on the highway and we are in discussions with Yorkshire Water and Kirklees Highways about possible causes for the bump, which is increasing in size)

We met and consulted with Jack from Kirklees Planning/Tree Department on 4 October 2024 and then spoke to Rob from RS Environmental Services who is a qualified tree surgeon, therefore we would like to request the following:-

3 x Limes ( numbered 1,2 & 3)

- 20% thinning of all canopies
- Suitable height reduction (can't remember if this was agreed by Jack)
- Removing small diameter branches evenly through the crowns
- Crown clean any deadwood and old stubs
- Reduce branches that hang over Richard Thorpe Avenue back to a suitable side branch to provide 5.5m ground clearance (from road and footpath)

1 x Copper Beech (numbered 6) and 2 x Sycamores (numbered 4 & 5)

- 10% thin and removal of any deadwood and old stubs

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
