The proposed development will provide much needed living spaces within the property.

A pre-application response dated 25 September 2024 for the proposed development was generally supportive. A number of issues were raised which has been mitigated through design and included as part of this application.

The rear dormer will be within permitted development limits. Furthermore, the rear dormer wall will be offset from the face of the rear external wall by more than 200mm. The total additional volume of the front and rear dormers will be 46.9m<sup>3</sup> which is less than the limit for semi-detached properties of 50m<sup>3</sup>.
