Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

All trees - Crown lift to 5m over driveway to allow for vehicle access and 3.5m over garden to allow for headroom. Reduce away from buildings and patio area to give 2-3m clearance as the branches are now touching the patio area and the corner of the house. Crown clean and thin by 15% as the neighbouring property has recently had branches fall from these trees into their garden so this would allow us to alleviate any further issues and create a tree life balance.

All works are to maintain the trees for future longevity and tree cover.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
