The proposed extension to the ancillary building (the subject of this application) is purely for the bulk storage of plastic storage containers (palletted) on the site, in order to significantly reduce the number of vehicular movements to and from the site.

The existing main building accommodates industrial & commercial processes and machinery for the basic blending and stirring process, combining liquids & powders (no chemical reactions, purely a blending/mixing process). Particle size reduction, using wet grinding equipment (bead mills), to produce stable products. Two filling lines, for automated filling of plastic storage containers. Quality control lab with air conditioning.
