The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR INSTALLATION OF ELECTRIC CAR
CHARGING POINT ON THE FRONT EXTERNAL WALL

At: 21, WEATHERHILL ROAD, LINDLEY, HUDDERSFIELD, HD3 3LD

In accordance with the plan(s) and applications submitted to the Council on 10-Mar-2025 subject to the condition(s) specified hereunder:-

1. The development shall be begun not later than the expiration of three years beginning with the date on which consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion, and to accord with Policy LP24 & LP35 of the Kirklees Local Plan, and the aims of the National Planning Policy Framework.

3. All fixings shall be drilled through a mortar joint and not through the face of the stonework. Once the electric vehicle charging equipment and wiring becomes redundant, all equipment, brackets and fittings shall be removed, with the fixing holes infilled with lime mortar to match the colour of the stonework.

Reason: To retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.
