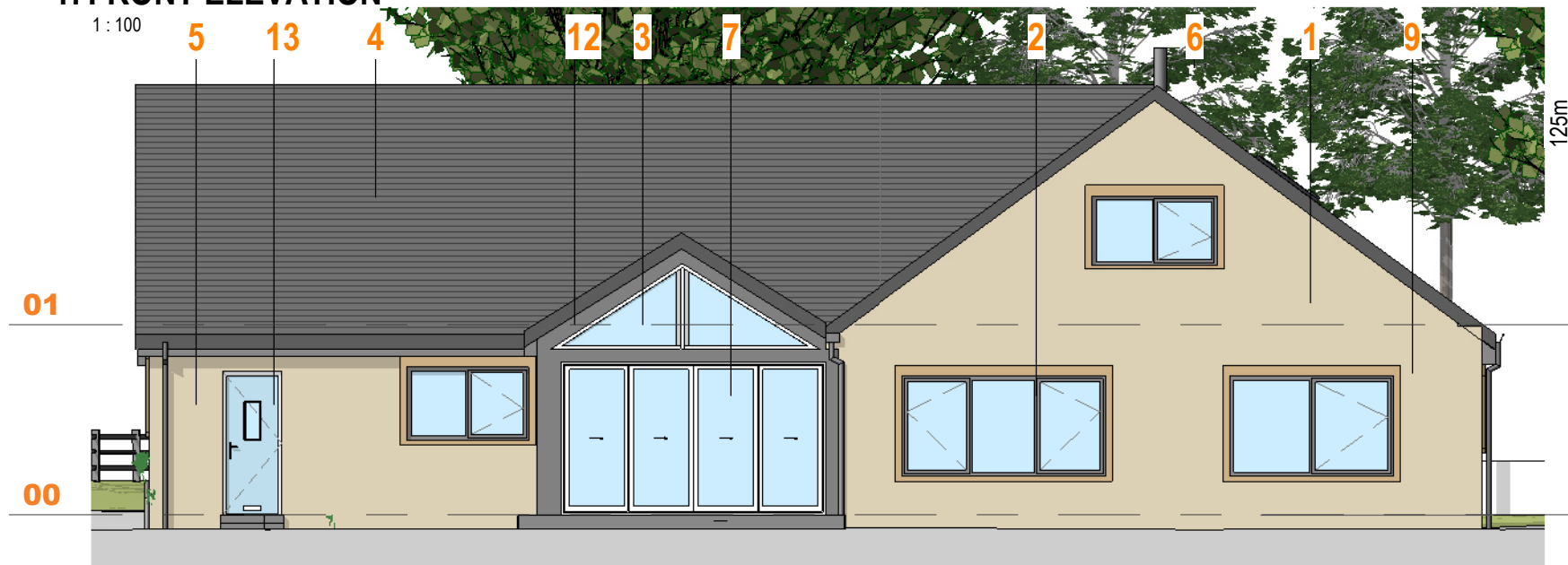




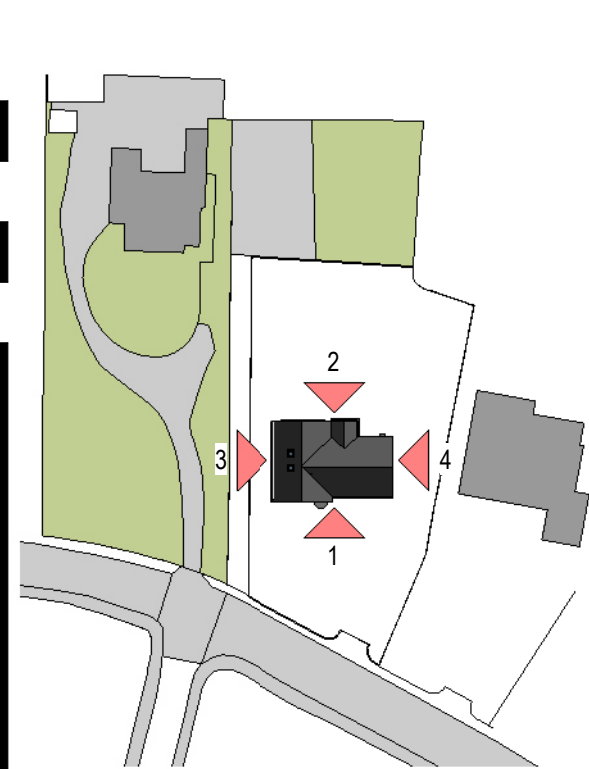
1: FRONT ELEVATION

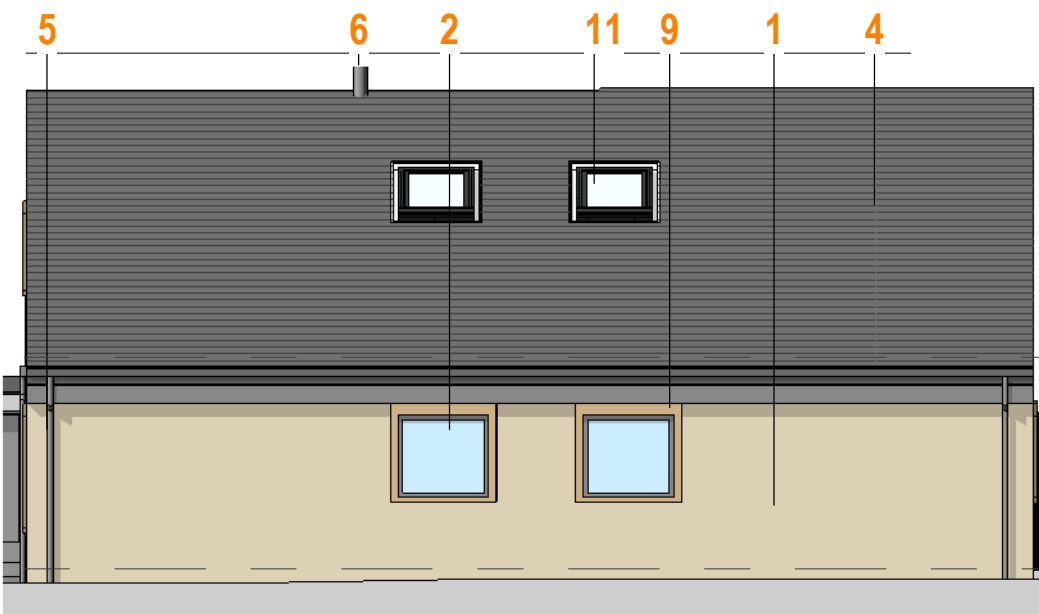

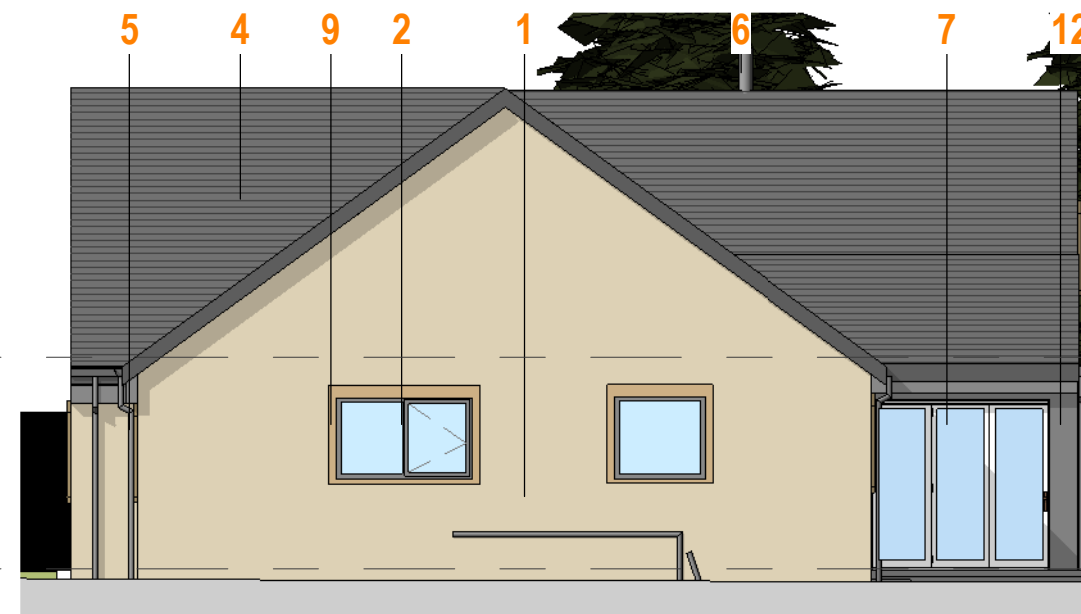
