Reasons for request:-

1. There is considerable dieback within the tree -resulting in large branches falling throughout the year .
2. When in leaf the healthy branches become too heavy for the tree to support and break and fall. It is the healthy branches which have fallen from the perimeter of the canopy which are the largest and caused most damage ,they have been too heavy to remove unless they are cut up.

3. There is a mushroom type fungus at the base of the tree that occurs every year.

5. I have enclosed photos of recent fallen branches and damaged caused

I believe the spread of the tree should be addressed to prevent further damage and possible injury to myself and my family.

4. A number of large branches fall every year, often spearing into the lawn. I would fear for my own safety if I was in the garden at the time this occurred.

Damage has been caused to my Conservatory Roof and a number of my Garden Cages and a Greenhouse have been destroyed.
