Install Renewable Energy Solution to include an MCS compliant Air Source Heat Pump and Roof fitted PV Solar Panels.

The Dailkin domestic air source heat pump will be installed at the rear of the house in the garden.

This is being sited centrally to be equidistant to neighbours on either side (allowing at least 3m and 5m to border respectively).

Dimensions are:

Height: 920 mm

Depth: 362 mm

Width: 1,250 mm

Sound Power level: 58 dBA

The noise calculation using MCS 020 for the heat pump sound was at 43 decibels (42.38 rounded), which is 1db higher than the acceptable threshold of >42 decibels

This unit will replace the current Gas Boiler and allow the removal of the Gas Supply and Meter.

16 x Aiko 455 Watt PV Solar Panels to be mounted on South facing roof (rear of house). All inverters and connections will be internal at the consumer box. This will allow the use of solar energy to supplement daily electricity use and store excess energy via battery for later usage.
