The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR LIFTING OF YORK STONE FLOORING TO ALLOW ACCESS TO EXCAVATE AND REPAIR LEAKING WATER SUPPLY PIPE AND REINSTATEMENT OF FLOORING ON COMPLETION

At: 236, ALMONDBURY BANK, ALMONDBURY, HUDDERSFIELD, HD5 8EJ

In accordance with the plan(s) and applications submitted to the Council on 23-Jan-2025 subject to the condition(s) specified hereunder:-

1. The development shall be begun within three years of the date in which this consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.

3. The York stone flags shall be re-laid on a permeable, breathable layer of limecrete in accordance with the submitted Method Statement as received on the 23/01/25 and retained thereafter.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.

4. The stone flags shall be pointed with an appropriate lime mortar to match existing as closely as possible and retained thereafter.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.

5. The 2 York stone flags must be reused where possible. If the flags are damaged, they shall be replaced with nature stone flags to match existing in terms of size, thickness, colour, texture and finish, and retained thereafter.

Reason: To ensure the satisfactory appearance of the development on completion to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.
