Description of Proposed Works

Please describe the proposals to alter, extend or demolish the listed building(s)

Proposal: to replace existing windows on the front elevation of the property.

Existing windows: there are 14 windows in total - 6 pairs and 2 singles. These are a Georgian style, each window consisting of 6 small, single glazed panes of glass, fitted in to timber frames, painted white. The present construction of the windows presents significant issues such as drafts, penetrating cold air and heat loss, resulting in poor energy efficiency.

Replacements: I would like to replace them with timber framed flush sash windows, painted white, with single pane, double glazed units with 16mm cavities. Openers to be hung on butt hinges, fitted with lockable fixings and fully weather-stripped. The benefits of gaining approval would be increased energy efficiency, lower heating bills, as well as improved comfort and home security.

Situation: the property is 1 of 3 weaver's cottages situated at the end of the terrace (raised above road level), facing on to Scholes Road. The other 2 cottages already have the benefit of this style of window. If approved, the appearance of all 3 cottages will match. The style chosen is also in keeping with the majority of similar properties in the wider surrounding area.

The proposal is to replace the existing windows, which have reached the end of their lifespan, to the front elevation of the property.

I would like to replace the existing windows with timber framed flush sash windows, painted white, with single pane, double glazed units, with either 16mm cavities (to meet building regulations) or 6mm cavities (to meet listed buildings requirements). Openers to be hung on butt hinges, fitted with lockable fixings and fully weather-stripped.

If approved, I have chosen to use Holme Valley Joinery for the works as they come highly recommended, are FENSA approved, and also familiar with dealing with planning requirements. They are happy to liaise with the Council directly with regards to any drawings / technical questions etc that may be required for the application process, and I give my consent for them do so.
