<ul style="list-style-type: none"> • Orientated to the south and west to benefit from natural sunlight, bringing more daylight into the depths of the house, reducing the need for artificial lighting • Proposed new roof lantern to bring light into depth of house and reduce reliance of artificial lighting

<ul style="list-style-type: none"> • Proposed glazing oriented to the south and west to benefit from natural sunlight, rooflights close to the front face of the existing house to bring natural light into the depth of the house

<ul style="list-style-type: none"> • Proposed permeable paving/hard standing within landscaping • The property is not situated within, or near a floodplane • The property is located within floor zone 1 and is not within 20m of a main river or flood defence
