Identification of Tree(s) and Description of Works

A line of 7 popular trees Starting T1 closest to the road and ending T7 furthest from the road.

Customer is requesting to remove the Trees to ground level.

There are a few reasons for this desire.

1. All the trees are showing large amounts of deadwood in them and the customer is finding increasing sized branches every week. The main residence is near the trees so there is the risk dead wood poses to the property also the cars. The family also have grandchildren that come and play and they want them to be free to play without danger.
2. T1 has large branches that go towards the house and has the largest amount of deadwood in it. The customer is worried that left unchecked this overhang will get worse and the tree eventually fall onto the house, as it is heavily weighted towards the house.
3. T2 is in decline, the top 3rd of the tree is dead and the base is showing signs of decline and losing bark.
4. T4 has two main stems that branch off early in the tree. The main stem is heavily leaning towards the house and the other stem is not large enough to counter balance the crown of the tree. This also has large amounts of dead wood in its crown.
5. A neighbor's popular recently came over in the recent storms and this has the client particularly worried.
6. The wind carries down the valley and pushes the trees towards the house and cars ect. This means that when branches do come off they often land on the roof and cars causing so far small damage, but the client is worried that it is only a matter of time before large snap outs occur.

The customer is more than happy to plant replacement trees further away from the property if they are allowed to remove the trees. They are happy to plant the same number if not more trees.

Most of the trees have lower wounds from previous snap outs, some of these have healed well but a few are starting to rot near to the base of the stems. (please see Pictures)

If the customer is not allowed to remove the trees he would like to request that you suggest what you would be happy with such as a Pollard or heavy reduction.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
