### **REFUSAL OF PERMISSION FOR DEVELOPMENT**

**Application Number: 2025/62/90469/E**

**In pursuance of its powers under the above-mentioned Act and Order the KIRKLEES COUNCIL (hereinafter called "The Council") as Local Planning Authority hereby refuses to permit:-**

**ERECTION OF FIRST FLOOR SIDE EXTENSION OVER EXISTING GARAGE  
AND ALTERATIONS TO PART CONVERT GARAGE TO LIVING  
ACCOMMODATION (WITHIN A CONSERVATION AREA)**

**At:** 3, PARK MEWS, FARNLEY TYAS, HUDDERSFIELD, HD4 6BX

**In accordance with the plan(s) and applications submitted to the Council on 26-Feb-2025, except as amended or specified, details of which can be found in the table below. The reasons for the Council's decision to refuse permission for the development are:**

1. The first floor side extension due to its scale and positioning, would result in an overbearing and oppressive impact on the first floor windows of the adjacent 2 Park Mews reducing light and outlook to the accommodation to the detriment of the occupants. To permit the proposals would be contrary to Policy LP24 of the Kirklees Local Plan, KDP5 of the House Extensions & Alterations SPD and Chapter 12 of the National Planning Policy Framework.

The extension would have an overbearing and oppressive impact on the first floor windows of the adjacent property. Amended plans have not been sought.

## Appeals to the Secretary of State

- If you are aggrieved by the decision of your Local Planning Authority to refuse permission for the proposed development or to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.
- As this is a decision for a householder application, if you want to appeal against your Local Planning Authority's decision then you must do so within 12 weeks of the date of this notice.
- If an enforcement notice is served or has been served relating to the same or substantially the same land and development as in your application and if you want to appeal against the local planning authority's decision on your application, then you must do so within:
  - i) 28 days from the date of this notice where the enforcement notice has been served,
  - ii) 28 days of the date of service of the enforcement notice or,
  - iii) 12 weeks of the date of this notice,which ever period expires earliest.
- Appeals must be made using a form which you can get from the Secretary of State at Temple Quay House, 2 The Square, Temple Quay, Bristol BS1 6PN (Tel: 0303 444 5000) or online at [the Planning Inspectorates Website](#) . Further information on the Planning Appeal process can be found online at [the Planning Inspectorates website](#).
- You must use the correct Planning Appeal Form when making your appeal. If requesting forms from the Planning Inspectorate, please state the type of application that the appeal relates to so they can send you the appeal form you require.
- The Secretary of State can allow a longer period for giving notice of an appeal, but he will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.
- The Secretary of State need not consider an appeal if it seems to him that the local planning authority could not have granted planning permission for the proposed development or could not have granted it without the conditions they imposed, having regard to the statutory requirements, to the provisions of any development order and to any directions given under a development order.
- In practice, the Secretary of State does not refuse to consider appeals solely because the Local Planning Authority based their decision on a direction given by him.

Please note, only the applicant possesses the right of appeal.
