The proposal seeks to change the use of the building at 17 Southfield Road, Almondbury, Huddersfield (HD5 8RY), from a former Working Men’s Club to a vibrant community-focused Event Hall with integrated Class E spaces. The project aims to rejuvenate this historically significant structure, which has served as a local hub for social interaction and recreation, by introducing spaces for small businesses, educational activities, and cultural events.

The building, which has suffered from neglect following its closure in 2023, will be repurposed to better serve the community. Key alterations include converting the existing halls into flexible spaces for business, education, and community activities, while retaining the building's architectural integrity. The front elevation will see minor modifications with new entrances to facilitate independent access to each unit.

The owners are committed to preserving the building’s legacy while ensuring financial viability. The proposed changes will breathe new life into the site, providing much-needed local employment opportunities and fostering a sense of community through continued public engagement and collaboration. The redevelopment will re-establish the building as a valuable, inclusive asset for the Almondbury area, promoting economic, social, and cultural development for years to come.
