The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR ERECTION OF SINGLE STOREY
EXTENSIONS, DETACHED GARAGE AND ALTERATIONS

At: 2-4, PIKE LAW LANE, SCAPEGOAT HILL, HUDDERSFIELD, HD7 4PL

In accordance with the plan(s) and applications submitted to the Council on 21-Feb-2025 subject to the condition(s) specified hereunder:-

1. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion, and to accord with Policy LP24 & LP35 of the Kirklees Local Plan, and the aims of the National Planning Policy Framework.

2. Removal of pointing shall be undertaken using handtools, not angle grinders. All pointing shall use an appropriate lime mortar specified for the joint thickness and stone type in terms of mix, aggregate and colour. The pointing shall be finished flush or slightly recessed. Note: Weatherstruck, strap or ribbon pointing is not permitted.

Reason: In the interest of preserving the heritage value of the Listed Building, in accordance with the requirements of Policy LP35 of the Kirklees Local Plan Chapters 2, 12 and 16 of the National Planning Policy Framework and pursuant to the requirements of S16 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

3. Rainwater goods shall be replaced in either timber, cast iron or sectional cast aluminium using a traditional section, and finished in black.

Reason: In the interest of preserving the heritage value of the Listed Building, in accordance with the requirements of Policy LP35 of the Kirklees Local Plan Chapters 2, 12 and 16 of the National Planning Policy Framework and pursuant to the requirements of S16 of the Planning (Listed Buildings and Conservation Areas) Act 1990.
