Description - Discharge of details reserved by condition 6 (historic building record) on previous permission 2022/90281 for Listed Building Consent for installation of five overhead electric line equipment portals on piers 1,4,6,7 & 9 with supporting wall brackets

The application seeks to discharge the condition as follows:

Condition 6 (Historic Structures Recording)

A Historic Building recording shall be completed to a Level 1 standard in accordance with Historic England Guidance. Reason: For the avoidance of doubt as to what is being permitted and to ensure the satisfactory appearance of the development on completion in order to retain the significance of the designated heritage asset and to accord with Policy LP35 of the Kirklees Local Plan, as well as Chapter 16 of the National Planning Policy Framework.
