We are requesting permission to install two new fences for health and safety reasons as we continue the use of our newly acquired church and continue to welcome new members and families with children:

1. North Perimeter Fence
  - o Type: Free-standing wooden fence
  - o Length: 35 meters
  - o Height: 1.8 meters
  - o Coverage: Northern boundary of the compound

This fence is needed to address the safety hazard posed by the approximately 2-meter drop from the church compound to the road (see attached images). There is currently no fall protection in place, and this becomes more critical with children around.

2. East Boundary Fence
  - o Type: Free-standing decorative fence
  - o Length: 35 meters
  - o Height: 1.8 meters
  - o Coverage: Eastern boundary of the compound

We also propose a fence along the east boundary of the property to prevent accidental falls into the adjacent river. This boundary presents a significant drop, making it essential to install a secure barrier for everyone's safety. The current boundary wall is 1 m high and a safety hazard for children.

By installing these fences, we aim to provide a safer environment for all church visitors and congregants. Thank you for considering our proposal. We look forward to your approval and any guidance you may provide.
