Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Consent sought to carry out the remedial tree works detailed in the attached tree report.

The work is minimal but necessary health and safety work. Both woodlands are heavily trespassed and have established footpaths running through them. This work seeks to safeguard the woodlands whilst also ensuring the safety of woodland users.

In order to safeguard the woodlands and their important flora, fauna and wildlife, all works will be carried out after the bird nesting period. No heavy machinery will be taken into the woodlands, all logs will be stacked and brash piled as eco-piles. The works will be carried out as sympathetically as possible so as not to cause any negative environmental impacts to these important sites.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
