I have moved approximately 7 metres of my existing fence back to the new boundary line and started to landscape the remaining area. Work was halted following receipt of letter from Mr Craig Nixon, Asset Management Officer at Kirklees Council informing that I need to apply for change of use of the council land or I would have to remove the fence and reinstate the land to its previous condition.
