The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR CREATION OF NEW SPILLWAY CHANNEL FOR SLAITHWAITE (HILL TOP) RESERVOIR REQUIRING CONSTRUCTION OF CONCRETE RETAINING WALLS INCLUDING ASSOCIATED ENGINEERING OPERATIONS AND WORKS AT BANK GATE MILL (G.II LISTED BUILDING)

At: SLAITHWAITE RESERVOIR, BANK GATE, SLAITHWAITE, HUDDERSFIELD, HD7 5XE

In accordance with the plan(s) and applications submitted to the Council on 10-Apr-2025 subject to the condition(s) specified hereunder:-

1. The development shall be begun within three years of the date in which this consent is granted.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by Section 51 of the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and to accord with Policies LP2, LP24, LP35 of the Kirklees Local Plan, the Council's adopted Highways Design Guide and the policies within Chapters 2, 12 & 16 of the National Planning Policy Framework

3. Notwithstanding the submitted details the retaining walls of the development hereby approved shall be externally clad in natural stone which shall be laid in courses to match the existing with all mortar pointing to be finished either flush or slightly recessed and no strap or ribbon pointing and thereafter be retained.

Reason: To provide a level of mitigation in relation to the less than substantial harm identified and in the interests of visual amenity to accord with policies LP24 and LP35 of the Kirklees Local Plan and policies within Chapters 12 and 16 of the National Planning Policy Framework.

The Secretary of State has power to allow a longer period for the giving of a notice of appeal and he will exercise his power in cases where he is satisfied that the applicant has deferred the giving of notice because negotiations with the Local Authority in regard to the proposed works are in progress.

Please note, only the applicant possesses the right of appeal.
