Description of Proposed Works

Please describe the proposed works

We are planning on a raised deck at the rear of our property, leading from the bi-fold doors in our kitchen; the raised decking will be at approximately 1.83 metres from the ground level measured at the wall, with just over half of the deck at a slightly higher level (one step higher sitting at approximately 2 metres from ground level measured at the wall). The lower level deck will have stairs leading down to the rear garden. The back of our property does not overlook any other buildings, however, we will be installing a privacy fence to our next door neighbours specification as our 2 gardens currently join by a lower level wall and fence. The rear of our house looks over open fields. We are wanting to install the above to make the most of the fantastic views from our house and to have access to the rear of our property, as at the moment there is none. We are aware that planning permission is required for any raised deck over 30cm in height. In addition, the space below the deck will be used for storage and eventually be enclosed with doors for access.

Drawing reference: Proposed raised deck from kitchen at 155 HD8 9DX.

2x 1:50 scale paper drawings @ A3 showing both existing and proposed top/back and side views. The proposed drawings show 2 adjoining raised decking areas one approximately 3.5M by 2.4M and the other slightly higher (by one step) at approximately 4M by 2.4M. The lower level deck at approximately 1.83M from ground level at the wall, providing access from the kitchen bifold doors and also the garden via approximately 13 steps. Under deck support beam and brace system with 2 banks per deck, posts spaced at 1 to 2M with 12 concrete pads to seat brackets. The balustrade material is as yet undecided. The deck itself will be a composite material.
