SUBMITTED PLANS WOULD BE LAWFUL WITHIN THE MEANING OF SECTION 192
OF THE TOWN AND COUNTRY PLANNING ACT 1990 (AS AMENDED), FOR THE
FOLLOWING REASONS:**

On the balance of probabilities, the occupation of the building at 91, Long Lane, Dalton, Huddersfield, HD5 9LH, by one child (aged 7-16 years old), with up to 2 non-residential carers at any one time, on a 10am-10.30pm / 10.30pm-10am rota basis, an Office Manager, present from 9am to 5pm / 10am -6pm for a minimum of three and up to five days, on weekdays, would amount to a material change of use from a Dwellinghouse (Class C3) to a Residential Institution (Class C2) as defined by the Use Classes Order 1987 (as amended).
