Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Starting from Right to left of the Garden Starting with T1 Conifer and Ending with T6 Sycamore.

Remove two Conifers T1 & T5 to Ground level these trees are competing with the Sycamores in the garden for light making the sycamores grow quicker and taller than they need to. By removing them it will give the sycamores more nutrients and so they will grow more naturally.

T2 Sycamore Crown lift the lower two branch's. these are long thin branch's which have grown out too far and are now resting on the phone lines that go through the area. due to their length they are increased risk of snapping and damaging the wires.

T3 Sycamore. Crown lift the lower 5 branch's leaving the larger branch that goes out to the left. the reason for removing these is that they come out a long way from the main stem and droop down a long way from their growth points meaning they are at an increased risk of snapping.

T4 Sycamore Crown lift the lower branch that comes down the banking towards the house again to reduce the risk of these long over grown branch's snapping.

T6 Sycamore crown lift to 4 meters from ground level. there are several phones lines and internet lines that run on the boarder of the property. the utilities workers have cut several branch's on this sycamore. By crown lifting the tree to 4M it would stop the tree interfering with phone and internet lines. also there is a public foot path next to the tree so it will stop the tree going over the foot path.

Also to remove epicormic growth from the bases of all the sycamores to reduce further works being required.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
