Condition(s) - Variation/Removal

Planning condition 37 is restricting the ability of the college to operate their existing buildings effectively. The condition does not appear to comply with the six tests in para 55 of the NPPF, as it is not reasonable or necessary given that the size of the built form for the partial redevelopment was fixed as part of the application. This type of condition restricting the operation of the whole college site has not been applied to other similar institutions in similar areas, locally or nationally. The condition appears to conflict with Kirklees Local Plan Policies LP9, LP7 and LP20. The highway authority consultee response to the application did not raise objections on highway safety and efficiency grounds and did not include an operational restriction in their list of suggested conditions.
