The proposal involves the construction of a single-storey rear extension with a flat roof, extending 6 metres from the original rear wall of the dwelling. The extension will remain within the existing side boundaries and will not project beyond the original side elevations. The flat roof will have a maximum height of 2.5 metres. External materials will be chosen to match those of the existing property to ensure visual consistency.

The extension will incorporate a ground floor toilet with appropriate drainage connections.
