Identification of Tree(s) and Description of Works

G1- A mixture of self seeded and immature trees and shrubs consisting of mostly Hollies, Oaks and Ash. The applicant's property is adjacent to a woodland and it has steadily encroached onto their property over the years. The applicant would like to clear an area along their boundary roughly 3-5 metres to stop the encroachment and help manage the boundary in the future.

There are no mature trees included in G1 to be removed and the removal of the smaller growth should benefit the established trees and shrubs further into the woodland due to increased natural light.

T1- A fairly well established Ash tree leaning over the applicants property. Due to the presence of Ash die back in several other ash trees in the area the applicant would like this removed before it becomes hazardous and potentially damages property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
