T1- Mature Beech to the rear of the property. The tree heavily shades the garden area and rear outbuildings. As it is a beech the crown is very dense when in leaf and doesn't allow much natural light through to the property and also drops significant amount of debris onto garden area and outbuildings with this in mind the applicant would like a crown thin of approx 20-25%

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
