Item 1 - We would like to slightly reduce the footprint/volume of the proposed development.

Item 2 - We would like to alter the materials to the rear elevation and partial side elevation from masonry to render.

Item 1 - To avoid existing surface water drainage routes (as identified on the attached plan). The elevations remain as proposed, with a minor adjustment to a wall position of the linking extension.

Item 2 - Upon further consideration and site investigation we feel render will tie in more seamlessly with the existing dwelling house and avoid unnecessary costs on largely unseen elevations.
