7. Identification Of Tree(s) And Description Of Works continued ...

These trees are excessively shading the bottom of my garden and sycamore trees are messy dropping leaves etc into my garden. The big leaves decompose slowly and create a slimy mess, as well as prolific seed production that leads to unwanted seedlings.

Some of the leaves on these trees are patchy black and are prone to pests and diseases such as sycamore lace bugs and anthracnose. The widespread root systems are problematic in the garden.

The entire Dick Wood has had no tree maintenance in the fifteen years I have lived here and many of them are much too tall.

I would like to fell entirely two trees, No 2 and No 3 in pink, as they are the most problematic shading my shrubs. I would like to heavily prune tree No 1 in orange. I would like to prune tree No 4 in orange, which is huge, if I can get my tree surgeon to do it.

I am concerned for the house foundations and subsidence issues as these trees have root systems, which are aggressive and no doubt will have an enormous spread.
