Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Previously an application was submitted to crown lift trees in G19 by 5.5m. This was refused because the council thought the work excessive. After assessing decisions on other sites to determine the amount of work which the council normally considers appropriate (eg applications 2025/91112 and 2025/91117), this applications seeks permission to crown lift these trees by 4m. Please note that 4m clearance is also as required by fire fighting equipment in the event of an emergency.

Using the council's own terminology, this application is to crown lift trees in group G19 removing small diameter branches only (less than 10 cm dia) to give 4 metres ground clearance.

Previously an application was submitted to crown reduce trees T11 and T12 by 20% as previously approved by the Planning Inspectorate who described this reduction as 'good practice'. This was refused because the council thought the work excessive. After assessing decisions on other sites to determine the amount of work which the council considers appropriate (eg application 2025/91188), this applications seeks permission to crown reduce these trees by a proportionate amount to that approved on other sites.

Using terminology previously approved by the council, this application is to crown reduce trees T11 and T12 by approximately 2.7m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
