## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The Sycamore tree is the second tree on the left after the driveway gates when viewed facing Whitley Road.

The tree has 2 main boughs, one of which has already fallen into the adjacent paddock field without damage. The remaining bough is cracked and the surrounding tree bark is also starting to split. It has been viewed by our local tree surgeon who has advised that it is likely to fall and that there are several broken branches trapped around it that are also likely to fall

The direction that the bough is leaning means it will most likely fall across the main boundary wall and onto Whitley Road. The tree is probably tall enough to completely block Whitley Road should it fall, and should therefore be considered dangerous

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
