A 3-storey property that has been extended and adapted to provide retail space at ground floor level with some units having additional first floor accommodation towards the rear part of the property. External elevations are constructed of red brick in two-stretcher to one-header bond. The front elevation was refaced in the mid-19th century with stucco render. Windows are timber with Georgian wire glazing, and doors are timber. A fire escape is provided along the rear of the original building at first floor level which discharges into a small courtyard area and ultimately through a fire exit on Chancery Lane. There are no other external areas associated with the property.
