One mature Oak that the applicant would like to reduce the overall profile of as it is starting to shade the garden area and overhang the neighbouring property.

The applicant would like to crown lift the tree as it is overhanging their drive and their neighbours roof quite noticeably. The applicant would also like to simultaneously crown reduce the tree to keep the height at a reasonable level and to keep the tree looking maintained thus preserving the amenity value.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
