## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Trees in group G22 of the attached tree survey.

Damage trees are causing to our roof drainage system due to the constant deposit of tree debris and broken rotten branches.

Trees are also overgrowing onto our property and covering the roof area. We are constantly clearing up branch debris from both our gardens and the public footpath between us and West House. Some of the fallen branches are quite large and have caused damage to fences but our concern is also for the people using the footpath.

Therefore, the application is to reduce the crown spread of this group so that there is no part overhanging the boundaries of 52 Latham Lane. A large branch has fallen in this last week and narrowly missed striking the occupants of 52 Latham Lane. This is a serious near miss which not only affects the occupants of 52 Latham Lane, but also users of the adjacent public footpath. This near miss confirms that branches are over extended and require reduction in accordance with BS3998.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
