Green Bins: These are provided for mixed dry recyclables, including:

Books (hardback covers removed), Cardboard, Deodorant sticks, Drink cans, food tins, and empty aerosol cans, Junk mail and envelopes,
Newspapers and magazines, Plastic bottles (with caps removed) - including pop, milk, and cleaning product bottles, Pots (e.g., yoghurt, soup, face cream), Telephone directories, Tubs (e.g., margarine, ice cream, laundry tablets), Trays (e.g., meat, ready meals, fruit and vegetable punnets)

These green bins are typically collected fortnightly, alternating with general waste.

Brown Bins: These are for garden waste, including: Grass cuttings, Tree and hedge clippings, Weeds (excluding controlled weeds), Plants and flowers,

Leaves, Twigs and bark, Small branches

This is an optional, annual subscription service, collected fortnightly between February and November.

Grey Bins: These are for general household waste that cannot be recycled. These are also collected fortnightly, alternating with green bins.

Household Waste Recycling Centres (HWRCs): Kirklees has several HWRCs where residents can dispose of a wider range of recyclable materials, including

glass, DIY waste, and other items not collected at the kerbside.
