## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1-T4 are a line of mature ash trees, elevated in the banking on the right hand side of no.9 Scar Ends address amongst other broadleaf species. These ash trees are approx 60-80ft tall, with low co-dominant multi stems and large thin, phototropic limbs growing towards the property and over the garden/driveway. The trees are showing signs of ash dieback with less foliage each season and more basal and epicormic/stress/reaction growth becoming apparent. The trees have shed a few large limbs in the last 24 months. The trees have a heavy lean towards the property and pose significant risk to the house should they fail. The owner of the property also has young children who are often playing in the garden.

A request to fell the ash trees on the grounds of the above reasons/ safety concerns is sought. Potentially we would like to leave a small pollard to help maintain banking stability. The ash trees are surrounded by a mix of healthy and well balanced broadleaf trees which will take the place of the currently dominating ash trees, therefore the visual and ecological impact of the removal of the ash trees would be minimal to the surrounding area and wildlife.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
