The red line application site is 0.0486 hectares in size, and the proposal is for 3 dwellings. The site forms part of a previously approved and partially constructed residential development (original approval ref. 2020/62/93954/W). The land is already cleared, has no trees, hedgerows, or semi-natural habitat, and has been prepared for residential use in line with the approved site-wide layout. There will be no loss or degradation of habitat as a result of this proposal. External changes are minimal and relate only to plot reconfiguration and modest landscape adjustments for access and parking. Based on the small site area, number of dwellings, and absence of habitat loss, this application qualifies as exempt under the de minimis threshold. A formal biodiversity metric is not required in this instance.
