Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1

Semi-mature ash (*Fraxinus excelsior*)

Measuring approximately 10 m in height with a canopy spread of 10 m and a stem diameter of 300 mm.

A co-dominant stem, approximately 150 mm in diameter, extends from the base of the tree over the newly proposed constructed bridleway.

Stem has included bark, which increases the likelihood of structural weakness and potential failure.

It is recommended that the limb extended over the path is to be removed in order to achieve a clearance of 5.2 m above the bridleway and to reduce the risk of structural failure (see Photo 5 and 6). In addition, the crown of the remaining tree should be lifted to a height of 3 m to provide improved access and visibility.

To maintain and facilitate accessibility of the bridleway connection path, all brambles and undergrowth should be cleared to achieve a 1.5 m clearance from the centre line of the route. Furthermore, the Harris fence panels currently in place should be removed, and the ivy growing on the tree should be severed at the base.

T2

Single hawthorn (*Crataegus monogyna*)

Measuring approximately 4 m in height and 3 m in width. It forms part of a mixed hedgeline and has previously been reduced to a height of 1.5 m.

To facilitate the construction of a new footpath connection, it is required that this tree be felled and the stump removed.

T3

Quercus robur (Oak)

Measuring approximately 6 m in height with a canopy spread of 2 m.

The tree exhibits historical damage at 0.5 m above ground level and is considered structurally compromised. It is therefore assessed as having low retention value.

It is recommended that the tree be felled and the stump ground to facilitate the construction of a new footpath connection.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
