Proposed Development / Change of Use

The application seeks planning permission for the change of use of the property from a standard residential dwelling (Use Class C3) to a Children's Residential Care Home (Use Class C2).

The proposed children's home will provide care and accommodation for up to two children (aged under 18) who require a supportive and stable home environment. Care will be delivered in line with Ofsted regulations and local authority requirements.

The home will be staffed by a small team of residential care workers, consisting of two to a maximum of four staff members on shift at any one time, including the registered manager, to ensure 24-hour care and supervision.

The property will remain in use as a domestic-style dwelling with no structural alterations proposed. Minor internal adaptations (such as fire safety measures) will be carried out to meet regulatory standards, but the overall character, layout, and appearance of the property will remain unchanged.

The proposal represents a low-intensity use of the dwelling, with activity comparable to a small family unit, and is intended to integrate positively within the local

Current Use of the Site

The property is currently classified as a residential dwelling (Use Class C3). At present, it is vacant and not occupied by tenants or owners. The building has most recently been used as a standard family home and remains in good condition, retaining the layout and features of a domestic residence.

The dwelling is therefore well-suited for continued residential use and, with minor adaptations, is considered appropriate for conversion to a small children's residential care home. No other commercial or alternative uses have taken place on the site.

Last Use of the Site

The property was last used as a standard family home within Use Class C3 (residential dwelling). It functioned as a typical domestic residence and has not been used for any commercial or non-residential purposes.

As the property has retained its residential layout and character, it remains well-suited for continued use in a residential capacity. This makes it naturally compatible for the proposed change to a small children's residential care home, which will operate in a family-style manner with minimal impact on the surrounding neighbourhood.

Justification – Biodiversity Net Gain (BNG) Not Applicable The proposed development relates solely to a change of use of the property from a standard residential dwelling (Use Class C3) to a Children's Residential Care Home (Use Class C2). No demolition, extension, or external building works are proposed. No garden, boundary, or landscape alterations are included in the proposal. The site is already fully developed as a dwelling and contains no habitats or features of ecological value that would be affected by the change of use. Only minor internal adaptations (e.g. fire safety compliance) will be undertaken. Given the above, the development falls within the de minimis exemption as it has no impact on biodiversity and does not trigger the requirement for Biodiversity Net Gain under Schedule 7A of the Town and Country Planning Act 1990 (as amended).
