Change of use of land to domestic garden.

Wingfield originally stood with no rear garden. The property sat protruding into a field. The walls at the rear of the house formed the actual freehold boundary line. The livestock in the field were able to walk right up to the rear wall and you could touch them through the window.

In early 2020, (exact date unknown), the previous owners of Wingfield bought an 11 metre strip of the field from the landowner so that the house had a rear garden. In the summer of 2020 they erected a fence at the 11 metre boundary line and they mowed the grass and used the area as a garden.

My family and I have lived at Wingfield for five years. We bought the house in September 2020. Since we moved in, we too have mowed the grass and used the strip of land as a garden - hanging washing, playing games, sitting out, entertaining etc.

The piece of land and the house, garage, drive and other areas of front garden are all included under a single freehold Title Plan.

It has recently been brought to my attention that the piece of land, despite being part of a single title plan, may still be classed as agricultural land. I am consequently making this full planning application to request that the use of the land be officially reclassified as domestic garden.
