Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Trees numbered upwards towards roadside (Dingley rd) for example T14(cottonwood) is closest to roadside and T1(sycamore) is furthest from roadside.

T1 sycamore to be crown lifted providing 4-5 metres ground clearance and sympathetic crown thin of approx 10-15%.

T2 Sycamore to be crown thinned approx 10-15%

T3 cottonwood to be crown reduced approx 4-5 metres and thinned approx 15%

T4 cottonwood to be crown reduced approx 4-5 metres and thinned approx 15%, deadwood in crown to be removed.

T5 sycamore to be crown lifted providing 4- 5 metres ground clearance and sympathetic crown thin of approx 10-15%.

T6 sycamore to be crown lifted providing 4-5 metres ground clearance and sympathetic crown thin of approx 10-15%.

T7 Lime to be crown lifted providing 4-5 metres ground clearance and sympathetic crown thin of approx 10-15%.

T8 cottonwood to be crown lifted providing 4-5 metres ground clearance and crown reduction & thin

T9 Lime to be crown lifted providing 5 metres ground clearance and sympathetic crown thin of approx 10-15%.

T10 cottonwood to be crown lifted providing 4-5 metres ground clearance and crown reduction & thin (deadwood and hazardous broken limbs present)

T11 Lime to be crown lifted providing 4-5 metres ground clearance and a sympathetic crown thin of approx 10-15% also reducing the crown in keeping with rest of tree line.

T12 cottonwood to be crown reduced approx 4-5 metres and thinned approx 15% also lifted away from driveway.

T13 Lime to be crown lifted providing 5 metres ground clearance and sympathetic crown thin of approx 10-15%.

T14 cottonwood to be crown reduced approx 5 metres and thinned approx 15-20% also lifted away from driveway and footpath/roadside. Significant large limbs have failed and landed on the road and footpath (see attached photos) presenting a danger to public.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
