Two of these documents relate to actual plans so shouldn't these plans have been placed in the **Plans** section on the Kirklees website. The details of these documents are:

- 1) Drainage/Foul Sewerage Assessment [id 1128401]. When this document is opened it has a title of Flood Exceedance Plan PV2511-APP-92-XX-DR-C-2501 Rev P05
- 2) Drainage/Foul Sewerage Assessment [id 1128402]. When this document is opened it has a title of Drainage Plan PV2511-APP-92-XX-DR-C-2500 Rev P06

The Plans section still has the following document in it:

1} Drainage Plan [id 1119360] PV2511-APP-92-XX-DR-C-2500 –P04

Shouldn't this document be in the **Superseded Documents** section??

Also **Architect Note, [Drainage / Foul Sewerage Assessment \[id 1126612\]](#) Size: 178KB 13/02/2026 - PV2511-92-XX-RP-C-7010-P01 Drainage Note**

In this note reference was made to Plan: PV2511-APP-92-XX-DR-C-2500-P05 Drainage Plan. Has Kirklees ever received this plan because I am unable to locate it on the planning web site?

As this document has not been uploaded on Kirklees website nobody knows what changes it included and have not been given the opportunity to make comments on them.

On 26.02.2026 there has been four extra documents uploaded on the Kirklees website for the above application number in the **Supporting Information** section. Three of these documents relate to actual plans so shouldn't these plans have been placed in the **Plans** section on the Kirklees website. The details of these documents are:

- 1) Drainage/Foul Sewerage Assessment [id 1128423]. When this document is opened it has a title of Flood Exceedance Plan PV2511-APP-92-XX-DR-C-2501 Rev P05
- 2) Drainage/Foul Sewerage Assessment [id 1128422]. When this document is opened it has a title of Drainage Plan PV2511-APP-92-XX-DR-C-2500 Rev P06
- 3) General [id 1128421]. When this document is opened it has a title of Levels Plan PV2511-APP-94-XX-DR-C-2400 Rev P03

As these plans have been uploaded onto Kirklees Planning website in a number of different sections, it is very confusing and difficult, to know which ones are the current plans and which ones are the superseded plans. Especially when they are scattered over a number of sections.

Also, many of these documents have a generic title rather a specific title, which again is very confusing i.e. on Kirklees Website, some just say drainage rather than a specific title it relates to i.e. Exceedance Plan.
