The KIRKLEES COUNCIL hereby give notice that LISTED BUILDING CONSENT has been granted for the execution of the works referred to:-

LISTED BUILDING CONSENT FOR ERECTION OF SINGLE STOREY LINK
EXTENSION AND ALTERATIONS TO GARAGE TO EXTEND LIVING
ACCOMMODATION

At: 1130, NEW HEY ROAD, SCAMMONDEN, HUDDERSFIELD, HD3 3FJ

In accordance with the plan(s) and applications submitted to the Council on 03-Nov-2025 subject to the condition(s) specified hereunder:-

1. The development hereby permitted shall be begun within three years of the date of this permission.

Reason: Pursuant to Section 18(1) of the Planning (Listed Buildings and Conservation Areas) Act 1990, as amended by the Planning and Compulsory Purchase Act 2004.

2. The development hereby permitted shall be carried out in complete accordance with the plans and specifications schedule listed in this decision notice, except as may be specified in the conditions attached to this permission, which shall in all cases take precedence.

Reason: For the avoidance of doubt as to what is being permitted and so as to ensure the satisfactory appearance of the development on completion, and to accord with Policies LP2, LP24 & LP35 of the Kirklees Local Plan and Policies within Chapters 2, 12 and 16 of the National Planning Policy Framework.

3. The external walls of the extension shall be constructed in matching materials to that of the host dwelling and the roof of the extension shall be infilled with matching tiles. These materials shall be thereafter retained.

Reason: In the interests of visual amenity and the heritage significance of the site, in accordance with Policies LP2, LP24 and LP35 of the Kirklees Local Plan and policies within Chapters 12 and 16 of the National Planning Policy Framework, Key Design

4. The windows proposed to the extension shall be of a match to the existing windows installed to the host property, including the thickness of glazing, and all of the windows and doors to the extension shall be constructed in painted timber only and retained thereafter.

Reason: In the interests of visual amenity and the heritage significance of the site, in accordance with Policies LP2, LP24 and LP35 of the Kirklees Local Plan and policies within Chapters 12 and 16 of the National Planning Policy Framework, Key Design
