Beech tree (noted as T1 on the attached sketch plan in respect of Section 7 of the form). Remove tree. The Beech tree is an early to mid mature specimen and is already a sizeable tree. It is felt that it will quickly outgrow its location given that it will further increase in size significantly given its relatively young age for the species type. There is evidence of a potential stress fissure to the trees main trunk from 1m up to 2m. Whilst fissures and frost crack are common to the species this is slightly larger than would be normally expected although at this present this time the current fissure is not considered to be excessively significant.

7. Identification Of Tree(s) And Description Of Works continued ...

There will remain a number of remaining young and semi mature trees in the immediate surrounding area which will offset any effects as a result of the Beech trees removal. In addition the tree is set well back from the general public domain (ie the Highway) being located to the rear garden area of the property and an adjoining row of terraced cottages. Therefore the loss of the Beech tree will not severely impact upon the visual amenities or setting of the Conservation Area.

Whilst pruning of the tree could be considered as an alternative, this would not sufficiently resolve the situation where canopy regrowth will occur and therefore be a temporary measure, whilst also setting in place an ongoing and unnecessarily costly process.

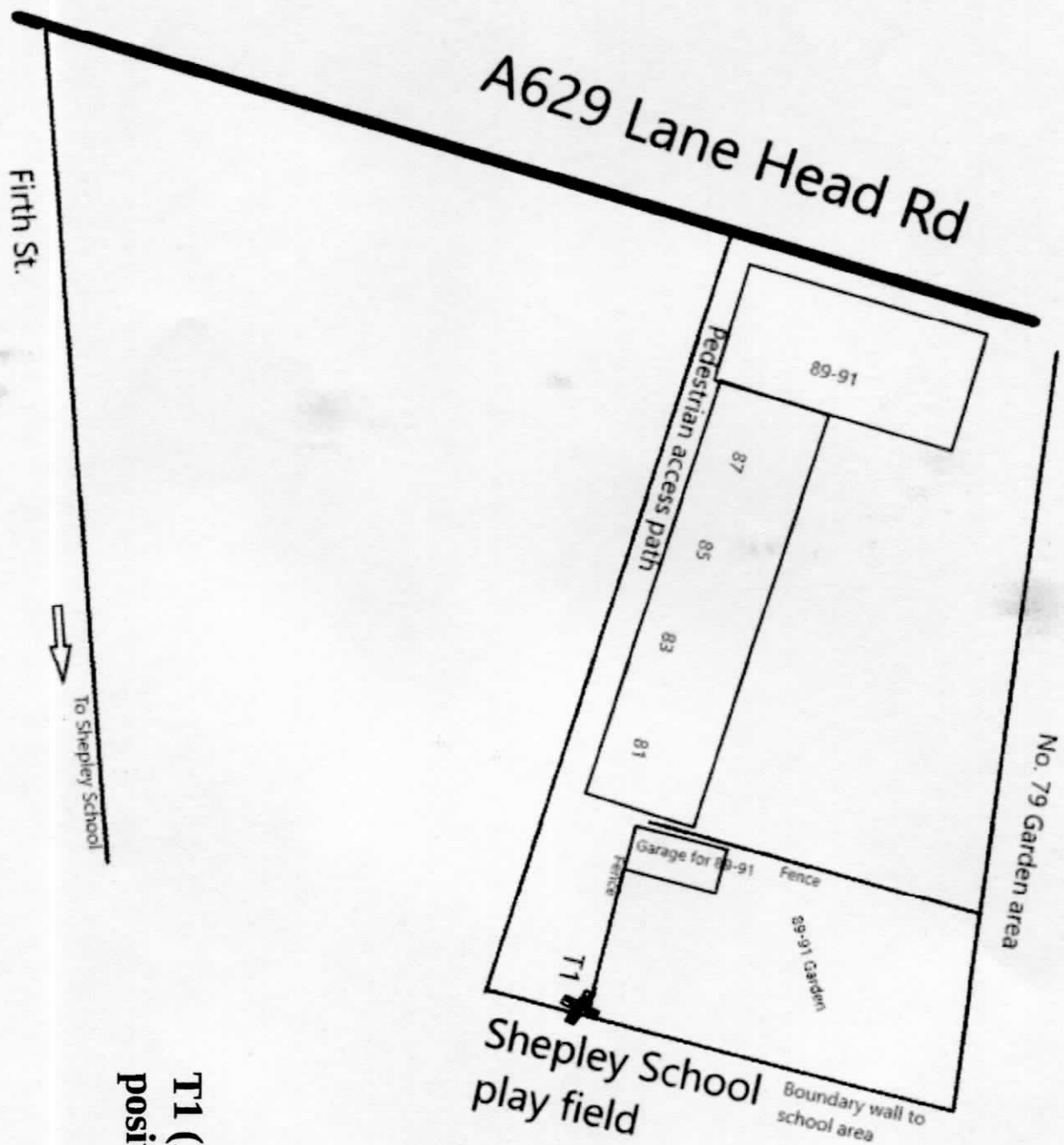
