Officers consider the principle of development for extending the existing building has the potential to be considered acceptable; however, it is recommended that the scale of development is reduced from the currently proposed scheme as officers are of the opinion that it would not accord with Policy LP57 of the Kirklees Local Plan and the provisions of Chapter 13 of the National Planning Policy Framework (NPPF). Any application which is submitted would need to be accompanied by a planning statement which addresses how the principle of the development within the Green Belt is acceptable in this case.
