1. Introduction

This statement has been prepared to address the applicability of the Biodiversity Gain Condition as set out in Paragraph 13 of Schedule 7A of the Town and Country Planning Act 1990 (as inserted by the Environment Act 2021) to the proposed development at 123 Trinity Street, Huddersfield.

2. Description of the Proposed Development

The proposal seeks planning permission for a change of use of the existing building. The development does not include any external alterations, extensions, landscaping works, or changes to the surrounding land. All works are confined to the internal areas of the existing building.

3. Legislative Context

The site falls below the threshold due to its small size being less than 25 sqm.

Under the Environment Act 2021, the Biodiversity Gain Condition is applied to most planning permissions granted for development in England. This condition requires that developments deliver at least a 10% measurable biodiversity net gain (BNG) compared with the pre-development baseline.

However, Paragraph 13(2) of Schedule 7A allows for certain exemptions, and Government guidance clarifies that the BNG condition applies only where a development would result in habitat loss, creation, or modification.

4. Applicability to the Proposed Development

The proposal at 123 Trinity Street does not include any operational development or works that would affect existing habitats. Specifically:

The application involves a change of use only, with no external works to the building or curtilage.

There is no removal, disturbance, or creation of vegetation or habitats on the site.

The existing site is entirely hard-surfaced or built form, with no measurable biodiversity baseline that could be affected by the proposal.

Given these factors, the proposal does not result in any change to the biodiversity value of the site. There is therefore no requirement to calculate or deliver a biodiversity net gain under Schedule 7A.

5. Conclusion

In summary, the proposed development:

The site falls below the threshold due to its small size being less than 25 sqm.

Involves no external or physical alterations;

Results in no habitat loss or creation; and

Has no effect on the site's biodiversity baseline.

Accordingly, it is considered that the Biodiversity Gain Condition set out in Paragraph 13 of Schedule 7A of the Town and Country Planning Act 1990 does not apply to this application.
