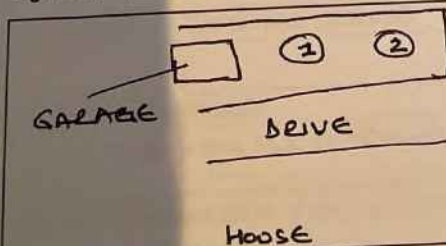

We wish to apply for work to be carried out on the chestnut tree to the right of our drive, which is adjacent to a wall & close to our garage.

The chestnut tree is approximately the same height as our 3 storey Victorian property.

Last year a ~~tree~~ branch fell across our neighbour's drive (number 30) in a storm blocking their drive but fortunately not crushing their car.

This year in storm Amy, several branches snapped, one bringing down the neighbour's internet & phone line which took a week to repair. Our neighbours are warned that the tree is dangerous & may damage their house.

Two separate tree specialists have assessed the tree & confirmed it is severely diseased. There are multiple very large branches with no growth this year which are damaged internally and at risk of falling especially when the sap rises.

They recommend taking the tree down to its main trunk (leaving the crown). It would be difficult to remove entirely due to location.
