I am applying for planning permission to carry out minor external alterations in order to operate the premises as a barbershop. The proposed works include:

Installing a new barbershop sign on the front elevation.

Replacing the existing front glass with a new roller shutter for security.

Setting the new glass frontage slightly further back, in line with neighbouring units that have the same layout.

The premises were previously used as a pharmacy. When we began making these changes, a Council officer visited and informed us that planning permission was required. We immediately stopped all works and returned the frontage to its original condition, pending the submission and approval of this full planning application.

These works are intended to ensure the shopfront matches the surrounding units and is suitable for use as a barbershop.
