Identification of Tree(s) and Description of Works

All species within the grave yard. This entire graveyard has been neglected for a number of years and the new owners wish to tidy it up and make it accessible once again for people to be able to pay their respects. There are also war graves within. The proposal is to remove all self seeded saplings smaller than 100mm DBH and any trees growing directly out of or affecting graves within the site. No mature trees will be touched. Also to remove the brambles and other ground cover to make this site accessible. This will then be managed through an ongoing management program.

Under the governments guide for burial ground managers my client has a legal obligation to maintain this ground so this CA permission will be the start of the process.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
